# NOTICE OF INQUIRY SUBSTANTIVE HEARING

Take notice that an inquiry will be conducted in the above matter by the Fitness to Practise Committee of the General Optical Council.

A substantive hearing will be proceeding:

## **Physical hearing**

The substantive hearing will take place at **09:30AM** on **Monday 03 November – Friday 14 November 2025** at the GOC offices: **Level 29, One Canada Square, London, E14 5AA**.

The Inquiry will be based upon the allegation submitted by the Council (see below) and will determine whether the fitness to practise of **Gregory Loftus-Boyd** is impaired by virtue of the provisions contained in section 13D(2) of the Opticians Act 1989.

#### **ALLEGATION**

The Council alleges that you, Mr Gregory Loftus-Boyd (01-18394), a registered Optometrist and Director of [redacted]:

- 1. On an unknown date in 2023 you made comments towards your colleague, Ms A regarding her appearance, in that you:
  - a. Asked Ms A if she was a [redacted] and proceeded to tell her that she looked like one; or words to that effect; and/or
  - b. Said to Ms A "no I think you look like one of those fortune tellers, it's the earrings, can you tell me the future" or words to that effect; and/or
- 2. On or around July 2023 you made comments towards your colleague, Ms A, including:
  - a. "when I think of [redacted] it makes my mouth water, like a dog does when they get a treat or a bone" or words to that effect; and/or
  - b. "The fact it's your last name makes my mouth wetter" or words to that effect;
- 3. On or around 22 July 2023 during a team meal you made comments towards your colleague, Ms B, including:
  - a. "Did you go too rough with him?" or words to that effect; and/or
  - b. "Did he have to use his safe word?" or words to that effect; and/or
  - c. "You have such small hand, I bet [redacted] loves that?" or words to that effect; and/or
  - d. "So it's like that, you're getting things out of him" or words to that effect; and/or
  - e. "Oh is it like that kind of situation, so he's paying for everything" or words to that effect
- 4. On or around 23 July 2023, you brought your dog into the store and upon the dog sniffing near Ms B's private area you made comments, including:
  - a. "No we don't do that, at least not until the second or third meeting" or words to that effect
- 5. On or around July 2023 you used your position of authority and requested two subordinates to loan you money, including:
  - a. Asking Mr D a pre-registration Optometrist to loan you £500; and/or
  - b. Asking Ms C an Optometrist to loan you £500; and/or
  - c. You arranged a staff loan for Ms C, signed the agreement with your own name instead of hers, and submitted it as authentic by using your own signature rather than Ms C's

- 6. Your conduct at 2(a-b), 3(a-e) and 4(a) above were
  - a. Inappropriate; and/or
  - b. Sexually motivated.
- 7. Your conduct at 1(a-b) and 5(a-b) above was inappropriate
- 8. Your conduct at 5(c) above was dishonest

And by virtue of the facts set out above, your fitness to practise is impaired by reason of misconduct.
